Be it remembered that a session of the County Commission of Stone County was held in the courthouse at Galena, on February 21, 2017. Those in attendance today were Presiding Commissioner Dennis Wood, Southern Commissioner Hank Smythe and Northern Commissioner Mark Maples.

#### Morning Session:

#### 9:00 AM

Presiding Commissioner Dennis Wood opened the meeting with the pledge of allegiance to the flag. Following the pledge of allegiance, Gavin Sowell delivered the prayer.

## Sales Tax Report

General Revenue Sales Tax receipts were up 23.38% for the month and up 7.67% for the year. Capital Improvement Sales Tax receipts were up 27.27% for the month and up 9.58% for the year. Law Enforcement Sales Tax receipts were up 27.27% for the month and up 9.58% for the year. The Local Option Use Tax is up \$74,714.80 from this time last year. Budget expenditures and revenues were provided for each department and reviewed.

On Tuesday, March 14, 2017 at 10:00 AM, Jennifer Wilson, nForm Architecture and Jack Dillingham, Piper Jaffrey will be here to discuss the future expansion project of the Law

Enforcement building. Presiding Commissioner Dennis Wood noted that an architect will need to be hired for this project and many open meetings with the public will need to be scheduled. Tiling of the second and third floors of the Historic Courthouse has been completed. The floor of the Treasurer's office will be worked on next.

Northern Commissioner Mark Maples opened discussion on the prescription drug monitoring program (PDMP). Commissioner Maples stated that he was advised that this program has a 10% chance of passing into law this year and asked that everyone contact their representatives. Bills regarding PDMP are MO HB 294; MO HB 716 and MO SB 72.

The Elected Officials discussed whether to buy ads individually or as a group. The Elected Officials discussed better communication with each other to try to share in costs of advertising.

Tom Martin, Emergency Management Director reminded the group that a Weather Spotter Class will be held this evening at the Reeds Spring High School. The class is open to everyone at no charge.

Treasurer Kristi Stephens reported that this is the year to advertise for bank bids. The bidding process will begin the first of April.

## **Approval of Commission Minutes**

## Award Bid - Assessor's Appraisal Software

Advertising in local newspapers resulted in the receipt of one bid from Ulrich Software. Assessor Brad Hudson reviewed the bid and recommended that the Commission award the bid to Ulrich Software. The implementation of the new system would begin July 1, 2017.

The matter to award the bid for Mass Appraisal Software to Ulrich Software was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood - yes. Matter carried.

#### Letter of Credit

A letter of credit for Grove subdivision (SUB-14-003), John Bowman, developer, in the amount of \$221,450.00 has expired and a reduced letter of credit requested. The water and sewer has been inspected by the County's engineer and verified completed. Remaining road work has an estimated cost of \$51,000.00. The estimate is good through October 2017. Discussion determined that the Commission does not wish to make it the Commission's policy to incrementally release bonds.

The matter to reduce and issue a letter of credit in the amount of \$75,000.00 contingent upon the receipt of \$389.50 in current costs, that the letter of credit is for one year only and that the letter of credit will not be extended past the one year was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood - yes. Matter carried. County Counsel William McCullah will notify the bank and Planning and Zoning will notify the developer.
