Approval of Commission Minutes

Schedule of Bills - 1

Sales Tax Report

General Revenue Sales Tax receipts were up 12.16% for the month and up 17.40% for the year. Capital Improvement Sales Tax receipts were up 18.41% for the month and up 16.70% for the year. Law Enforcement Sales Tax receipts were up 18.41% for the month and up 16.46% for the year. The Local Option Use Tax is up \$40,918.0 from this time last year.

Discuss Petition to Vacate Morris Acres Subdivision

Eddie Wolfe, presented before the Commission the petition to vacate Morris Acres Subdivision. Presiding Commissioner Dennis Wood stated that no one had come in to speak in favor of or in opposition to the vacation petition. County Counsel William McCullagh's stated that the affidavit for proof of publication has been provided. The matter to sign an order to vacate Morris Acres Subdivision pending execution with formal order to follow was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood – yes. Discuss Resolution of IRS Recommendations

County Counsel William McCullah came before the Commission with a Policy Concerning Personal use of County/Vehicles by Road & Bridge Employees. As per IRS recommendation, effective May 1 2018, all County Road & Bridge Employees who drive county-owned vehicles shall keep a record of actual miles driven on personal matters including from home to work base and from work base to home. Employees shall submit the mileage records to the County Clerk each month.
