## THE COUNTY COMMISSION OF STONE COUNTY, MISSOURI May 10, 2018

Be it remembered that a session of the County Commission of Stone County was held in the courthouse at Galena, on May 10, 2018. Those in attendance today were Presiding Commissioner Dennis Wood, Southern Commissioner Hank Smythe and Northern Commissioner Mark Maples.

### **Morning Session:**

#### 10:11 AM

Presiding Commissioner Dennis Wood opened the meeting with the pledge of allegiance to the flag. Those present for this meeting today are as follows: Matt Selby, Prosecuting Attorney; Earl Johnson, IT Director; Rick Dickerson & Jimmy Faucett, Stone County Maintenance Department; Debbie Scobee, Circuit Clerk; Kristi Stephens, Treasurer; County Counsel William McCullah; Denise Dickens, Commission Administrative Assistant and Tena Foster, Stone County Clerk's office.

#### **Approval of Commission Minutes**

The matter to approve the minutes for Stone County Commission meeting dated May 8, 2018 was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood – yes. Minutes ordered approved.

#### Schedule of Bills - 1

Presiding Commissioner Dennis Wood presented a schedule of bills that have been submitted to him from the County Clerk's office in the amount of \$11,649.28 (readjusted). This matter to accept the bills for payment was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood - yes. Order to pay carried.

#### Schedule of Bills - 2

Presiding Commissioner Dennis Wood presented a schedule of bills that have been submitted to him from the County Clerk's office in the amount of \$17,817.95. This matter to accept the bills for payment was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood - yes. Order to pay carried.

#### **Open Bid-Prosecuting Attorney office vehicle**

After advertising in Local News-Papers, no bids were received. Prosecuting Attorney Matt Selby has been in contact with Hamilton Ford, Oakley Auto World & Tri-Lakes Motors. Mr. Selby came before the Commission to discuss his recommendations after looking at several different vehicles:

- 1) Tri-Lakes Motors 2017 Ford Escape for \$22,990.00
- 2) Oakley Auto World 2015 Jeep for \$ 20,500.00

Prosecuting Attorney Matt Selby recommended using Tri-Lakes Motors for the 2017 Ford Escape. The matter to accept the recommendation and award the bid to Tri-Lakes Motors for the 2017 Ford Escape with the agreement that the Restitution Board would match what the Stone County Commission budgeted for the Prosecuting Attorneys vehicle. (Which the County had agreed to budget \$10,000.00) the remaining balance would come out of the Prospecting Attorneys Discretionary Fund was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood - yes. Matter carried. Adding one more vehicle to the County Fleet, leaving the PA with two vehicles.

#### Schedule of Bills - 3

Presiding Commissioner Dennis Wood presented a schedule of bills that have been submitted to him from the County Clerk's office in the amount of \$20,000.00 to purchase Prosecuting Attorney's Vehicle. \$10,000.00 from budget plus \$10,000.00 from restitution board. This matter to accept the bill for payment to purchase Prosecuting Attorney's Vehicle was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood - yes. Order to pay carried.

#### Award bid-construction of the Judicial Building Expansion

The County accepts the bid for R.E. Smith Construction Co. \$4,812,000.00 as submitted on March 20, 2018. This matter to accept the bid for R.E. Smith was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood - yes. Matter carried.

#### Award bid for Jail Roof

Rick Dickerson & Jimmy Faucett Maintenance Department recommended using Dales Roofing in the amount of \$24,345.00 to repair the jail roof. The bid was within budget and had a better warranty. The matter to accept the recommendation and award the bid to Dales Roofing for \$24,345.00 was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood - yes. Matter carried.

It was also mention that there is a part of the Circuit Clerks roof (in closet by court room c) in need of repair and Presiding Commissioner Dennis Wood requested that maintenance needs to figure out the problem and get it repaired as soon as possible. Discussion only, no decisions made.

#### Audit Draft Report of Standard & Poor

Kristi Stephens, Treasurer received through the Counties financing agent Piper Jaffray and Company the Preliminary Audit report of Standard and Poor's concerning the Counties global ratings. County Counsel William McCullah was to reply within two hours after receiving the report. County Counsel William McCullah stated that there could have been some changes but that would cause more of a delay so the consensus of the County Commission is to approve the Standard and Poor's Preliminary Audit report and to authorize Piper Jaffray & Co. to convey that information to Standard and Poor's. Presiding Commissioner Dennis Wood also stated that on May 22<sup>nd</sup> the County should have confirmation by Noon on the financing and interest rates that will be available for the expansion of the Judicial building.

#### Sales Tax Report

General Revenue Sales Tax receipts were down -9.97% for the month and up 11.63% for the year. Capital Improvement Sales Tax receipts were down -12.93% for the month and up 10.55% for the year. Law Enforcement Sales Tax receipts were down -12.93% for the month and up 10.36% for the year. The Local Option Use Tax is up \$62,029.3 from this time last year.

# *POLICY REVISED* CONCERNING PERSONAL USE OF COUNTY\VEHICLES BY ROAD & BRIDGE EMPLOYEES

As per IRS recommendation, effective May 1 2018, all County road & bridge employees who drive county-owned vehicles shall keep a record of actual miles driven on personal matters, including from home to work base and from work base to home. Employees shall submit the mileage records to the County Clerk each month. *The value of such use will be calculated at the County's reimbursable mileage rate and will be included in the employee's taxable compensation.* The matter to accept the revised Policy was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood - yes. Smith Construction. (May 23<sup>rd</sup> is the last day the County bid is good with R.E. Smith Construction.)
