County Clerk discuss Workers Comp Claims

Cindy Elmore, County Clerk & Donna McConkey Chief Deputy County Clerk came before the Commission with information on Workers Comp Claims. When the county clerk becomes aware of a worker's comp claim and the County Clerk is reasonably certain that they have all the medical bills, the County will pay up to \$3,300.00 instead of turning it in to our work comp carrier. Workers comp claims will be payed out of the workers comp expenditure line, even though the County is aware that the line is over budget due to the unexpected premium increase payed in March and knowing it will go further over budget for the remainder of the year. This matter to set a limit for the County to pay up to \$3,300.00 for a worker's comp claim was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood - yes. Matter carried.

Discussion of the Coroners additional compensation

The Coroners additional compensation line in the 2018 budget appropriation will be moved by the County Clerk Cindy Elmore to the Coroners Annual Salary line due to the one-time compensation.

Sales Tax Report

General Revenue Sales Tax receipts were down -9.97% for the month and up 11.63% for the year. Capital Improvement Sales Tax receipts were down -12.93% for the month and up 10.55% for the year. Law Enforcement Sales Tax receipts were down -12.93% for the month and up 10.36% for the year. The Local Option Use Tax is up \$62,029.3 from this time last year.
