Whereas, we recognize and honor Dean Webb, a resident of Reeds Spring, Stone County, Missouri, for his numerous contributions to the music and entertainment industry, and to his County, to the State of Missouri, and to his community;

Whereas, Dean Webb was one of the founding members of The Dillards, a bluegrass music band that achieved national and international fame for musical compositions and performances;

Whereas, the Dillards achieved particular fame as guest performers and actors on *The Andy Griffith Show* that was originally broadcast nationwide on the CBS television network in the 1990's, and has been in continual syndication ever since;

Whereas, Dean Webb and Mitch Jayne co-wrote *Old Home Place*, a musical composition that has received widespread critical acclaim and has been featured in its performances and on a number of music albums from 1963 to 2014;

Whereas, Dean Webb was in 2009 inducted into the International Bluegrass Music Hall of Fame;

Whereas, Dean Webb is a founder of the Missouri Boatride Bluegrass Band;

Whereas, Dean Webb is a founder of the Lake Concert Series based in Kimberling City, Stone County, Missouri;

Whereas, Dean Webb has organized and participated in many other community and civic activities;

Whereas, Dean Webb has been assisted in his musical, community, and civic activities by his beloved wife, Sandy Webb;

Now, Therefore, Be It Resolved that we honor Dean Webb for his generosity and his lasting contributions to the citizens of Stone County and the State of Missouri;
