
Sign CenturyLink Telephone Contract



Connell Insurance Discuss Employee Health Insurance Renewal

Shawn Mayr, Connell Insurance and My-Linh Smith, Cox Health Plan presented the Commission revised renewal rates with several options. The Commission reviewed and discussed several options and how they would affect Stone County employees.

The matter to sign an insurance renewal with Cox Health using option 7, at a rate increase of \$17.00 a month per employee, giving Stone County Employees the same coverage although deductible cost raised to \$6,000.00 and out of pocket cost to \$7,500.00, emergency room deductible cost and Copay stays the same, was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Wood – yes. Matter carried, renewal option 7 signed.
