Planning & Zoning Board Recommendations

RR-20-001 Richard & Theresa White are requesting to re-zone their property located off of State Highway 13, Branson West, Mo (parcel #11-8.0-27-000-000-028.006, 11-8.0-27-000-000-028.010 & 11-8.0-27-000-000-028.011) from A-R- to C-2 for a HVAC Business. The Board voted unanimously (8 to 0) to recommend APPROVAL of the re-zoning.

Presiding Commissioner Mark Maples allowed time for anyone to speak for or against the recommendation, Bill Anderson, All Season Comfort Systems came forward speaking for the rezoning. No one came forward against it.
