The Board voted 10 to 0 to recommend DENIAL for the Re-zoning. Presiding Commissioner Mark Maples allowed time for anyone to speak for or against the recommendation. Ryan Hagedorn spoke in favor of the rezoning, and several people came forward opposed. The matter to approve the recommendation of the Planning and Zoning Board on the request to rezone (parcel #05-8.0-34-000-000-003.000) for a Micro Outdoor Wedding Venue was brought to decision by roll call vote: Smythe – yes; Maples – yes; Blades - yes. matter carried. Re-Zone DENIED.

The Board voted 7 to 3 to recommend APPROVAL for the Re-zoning. Presiding Commissioner Mark Maples allowed time for anyone to speak for or against the recommendation. Hannah Jochims and Cathy Jochims spoke in favor of the rezoning, and Leah Eden came forward opposed. The matter to approve the recommendation of the Planning and Zoning Board on the request to re-zone (parcel #05-9.0-29-000-000-006.002) for a campground was brought to decision by roll call vote: Smythe – no; Maples – no; Blades - no. matter carried. Re-Zone DENIED.

RR-24-007 – Timothy Magill and Pamela Dixon are requesting to re-zone their property located at 3927 Joe Bald Road, Kimberling City, MO (parcel #14-3.0-07-001-008-016.000) from C-2 to RR-1 for a Residential Home.
