ORDER FOR REMOVAL OF CERTAIN EASEMENTS FROM COUNTY MAPPING

WHEREFORE, pursuant to the authority granted by the Revised Statutes of Missouri, and after considering the Petition, evidence adduced, the County Commission of Stone County, Missouri, finds as follows:

- Petitioners have filed a petition with this Commission.
- Petitioners are the owners of the two (2) parcels of land located in Stone County, Missouri, to wit: Parcel Number: 08-6.0-13-000-001.024 and Parcel Number: 08-6.0-13-000-000-001.067.
- Petitioners have owned said parcels of land in excess of ten (10) years as husband and wife or as trustees of the Revocable Living Trust Agreement of Robert J. Toolen and Cynthia L. Toolen, dated April 7, 2006.
- The legal descriptions of petitioners' parcels speak to an easement to the center line of a forty-foot roadway betwixt the parcels.
- Said "roadway" is known as Little Road Lane and appears on the Stone County map (administered by the county assessor's office) including petitioners' said easements.
- $6.\ \ Said$ "roadway" is utilized exclusively as ingress and egress for the properties touching said roadway.
- Petitioners' inspection of the land records of Stone County, Missouri reveals no such roadway of record.
- Whereas said "roadway" terminates at the northern border of petitioners' parcels and petitioners' parcels are respectfully situated on the western and eastern side of said

"roadway", petitioners' easements are nullified by operation of law pursuant to the doctrine of

9. The removal of petitioners' easements from the Stone County map is not detrimental to any property touching said "roadway".

WHEREFORE, to the extent that the County Commission has authority to do so, it is ordered that all departments and agencies of the County, Missouri that the "roadway" known as Little Road Lane shall terminate at the southern border of Parcel Number: 08-6.0-13-000-000-001.024 and Parcel Number: 08-6.0-13-000-000-001.067 and that the Stone County map as administered by the Stone County Assessor reflect such.
