Approval of Commission Minutes

Gary Clark came before the Commission to speak on the petition to vacate a portion of platted open space in Edgewater Village Phase 6 Subdivision Patio Homes. The Commission will meet at Edgewater Village Phase 6 Subdivision on June 13, 2024 at 11:30 AM.

Planning and Zoning Recommendations

RR-24-011 – Jesse Coin is requesting to re-zone their property located at 47 Hayes Spring Drive, Crane MO (parcel #02-7.0-35-000-000-005.001) from RR-1 to A-R to allow farm animals. The Board voted 9 to 2 to recommend DENIAL of the Re-zoning. Presiding Commissioner Mark Maples allowed time for anyone to speak for or against the recommendation. Jesse Coin and Laura Nelson came to speak in favor of the rezoning, and Anatasesa Bulkly came forward opposed.

Presiding Commissioner Mark Maples recommended putting a condition on the re-zoning to limit 1 hooved animal and a limit to 8 feathered animals on the property. The matter to approve the condition was brought to decision by roll call vote: Blades – no; Smythe – no; Maples – yes. Condition DEINED.

The matter to approve the recommendation of the Planning and Zoning Board on the request to re-zone (parcel #02-7.0-35-000-000-005.001) for farm animals was brought to a decision by roll call vote: Smythe – yes; Maples – no; Blades - yes. matter DENIED.

RR-24-012 – Ty Graves is requesting to re-zone his property located at 361 E. State Hwy 248, Reeds Spring, MO (parcel #08-7.025-000-000-009.001) from M-2 to RR-1 for a single-family home. The Board voted 11 to 0 to recommend APPROVAL of the Re-zoning. Presiding Commissioner Mark Maples allowed time for anyone to speak for or against the recommendation. Ty Graves came to speak in favor of the rezoning, and no one came forward opposed. The matter to approve the recommendation of the Planning and Zoning Board on the request to re-zone (parcel #08-7.025-000-000-009.001) for a single-family home was brought to a decision by roll call vote: Smythe – yes; Maples – yes; Blades - yes. matter carried. Re-Zone APPROVED.

Susan Kroupa came to speak in favor of the rezoning, and no one came forward opposed. The matter to approve the recommendation of the Planning and Zoning Board on the request to re-zone (parcel #14-9.0-31-004-013-043.000) to **allow for a nightly rental application** was brought to a decision by roll call vote: Smythe – yes; Maples – no; Blades - yes. matter carried. Re-Zone APPROVED.

RR-24-014 - Tom and Colby Hosick is requesting to re-zone their property located on lot #4 and 22' N to GFTL of the Valley View Beach Subdivision at 139 Greenvalley Lane, Branson West, MO (parcel #13-3.0-07-002-003-001.000) from R-1 to RR-1 to allow for a nightly rental application. The Board voted 11 to 0 to recommend APPROVAL of the Re-zoning. Presiding Commissioner Mark Maples allowed time for anyone to speak for or against the recommendation. Tom Hosick came to speak in favor of the rezoning, and no one came forward opposed.
