Be it remembered that a session of the County Commission of Stone County was held in the courthouse at Galena, on September 5, 2024. Those in attendance today were Presiding Commissioner Mark Maples, Southern Commissioner Hank Smythe and Northern Commissioner Wayne Blades.

Presiding Commissioner Mark Maples opened the meeting with a pledge of allegiance. Those that were in attendance were Joy Wilson, Planning and Zoning Director; Commissioner; Captain Randall Bennett, Stone County Jail; Jesse Bush; William McCullah, County Counsel and Sarah Perry, Stone County Clerk's Office.

Schedule of Bills - 1

Jail Inmate Food Services

After reviewing bids from Prodigy Solutions, Trinity Services Group and Tiger Correctional

Services, Captain Randall Bennett – Stone County Jail recommended Trinity Services Group for

the jail inmate food services. Trinity Services Group charges a flat rate of \$3.77 per meal with a

program for inmates to purchase additional food; the jail would get 20% commission from those

additional purchases. The matter to accept Captain Randall Bennett's recommendation was

brought to a decision by a roll call vote: Blades – yes; Smythe – yes; Maples – yes.

The lowest bid has a sliding scale - population drops below 80 meals and the cost is \$7.40.
