**Approval of Commission Minutes**

The matter to approve the minutes for Stone County Commission meetings dated December 02, 2025, was brought to decision by a roll call vote: Weathers – yes; Smythe – yes; Blades – yes. Minutes ordered approved.

### ORDER CONCERNING PLANNING & ZONING COMMISSION AND BOARD OF ADJUSTMENT QUORUMS AND VOTING

Whereas, Section 64.805 RSMo requires that a resident be appointed to the Planning & Zoning Commission from each township of the County except a township in which there is no unincorporated area.

Whereas, there are nineteen townships in the County in which there are no unincorporated areas.

Whereas, Section 64.870 requires that the Board of Zoning Adjustment be comprised of five members.

Now, therefore, it is ordered as follows:

1. Concerning meetings of the Planning & Commission; 10 members are required for a quorum, and more than half of the members present must vote in favor of a proposal for it to pass.
2. Concerning meetings of the Board of Adjustment, three members are required for a quorum, and more than half of the members present must vote in favor of a proposal for it to pass.

**Effective Date.** This Order shall become effective on December 4 2025.

The vote was Presiding Commissioner Weathers, yes; Commissioner Smythe, yes; Commissioner Blades, yes.
