<u>SUB-23-028</u> – Barnes Table Rock Investments, LLC is requesting to rezone their property located on Lot #18 of the Table Rock Village Lots 1 – 18 Subdivision at 276 Fountain Lane, Kimberling City, MO. (parcels #14-3.0-05-002-002-005.000) from R – 1 to R – 3 for a Sober Living/Drug Rehabilitation Center. Approximately 6.20 acres. The board voted 11 to 0 recommend Denial of the Sober Living/Drug Rehabilitation Center. Presiding Commissioner Mark Maples allowed time for anyone to speak for or against the recommendation. George Hurlburt, Dawn Bufford, Michael Butlacy, and Jacqulyn Camper came forward to speak opposed to the rezoning. The matter to approve the recommendation of the Planning and Zoning Board on the request (parcels #14-3.0-05-002-005.000) for a Sober Living/Drug Rehabilitation Center was brought to decision by roll call vote: Blades – yes; Smythe – yes; Maples – yes. Rezone DENIED. **<u>RR-23-030</u>** – Shepard of the Hills Development, LLC is requesting to re-zone their property located off State Hwy 76, Branson, MO (parcel #12-5.0-21-000-000-006.001) from A-1 to C-2 for a Horse Trail Ride Business. The Board voted 11 to 0 to recommend APPROVAL of the Re-zoning. Presiding Commissioner Mark Maples allowed time for anyone to speak for or against the recommendation. No one came to speak in favor of the rezoning, and no one came forward opposed. The matter to approve the recommendation of the Planning and Zoning Board on the request to re-zone (parcel #12-5.0-21-000-000-006.001) for a Horse Trail Ride Business was brought to decision by roll call vote: Smythe – yes; Maples – yes; Blades - yes. matter carried. Re-Zone APPROVED.
