Table Rock Lake Area Chamber- Yearly Update

Sheila Thomas TRLCC came before the Commission to give a recap of 2019 marketing and events. The Chamber is asking the Stone County Commission for \$70,000.00 to be spent on tourism marketing, \$15,000.00 for the Economic Development Program.

Ken Smith and Dennis Wood spoke in support of the Chambers request for 2020.

The Commission did not make any decisions regarding this request for the 2020 budget at this time. The Commission thanked Mrs. Thomas for all she does for the County, it is greatly appreciated!

Appoint Developmental Disability Board Members

Ladella Thomas with the Stone County Disability Board came before the Commission after advertising in local newspapers, the Stone County Developmental Disability Board received 5 applicants and interviewed 4. It was recommended to re-appoint Randy Moore for another three-year term, and appoint Joe Pate and Lisa Rau for 3-year terms starting January 1, 2020 to the Stone County Developmental Disability Board.

Personnel Policy Amendment

County Counsel William McCullah came before the Commission to discussion the 90-day probation period, for Road & Bridge (new hire employees) purchasing boots. It was recommended by County Counsel William McCullah to leave the Personnel Policy the same, but to add a contract for all New Hire R&B employees to sign a letter when hired, that after a 60-day probation period the County will reimburse the cost of their safety boots. If the employee terminates before the 60-day probation period the money owed to the County will be deducted from their last pay check. This matter to accept the recommendation for a 60-day probation period (not 90) to reimburse purchase for R&B new hire boots, or money owed to the County will be deducted from their last pay check was brought to decision by a roll call vote: Smythe – yes; Maples – no; Blades - yes. Matter carried.
