Approval of Commission Minutes

The Board voted unanimously 13 to 0 to recommend APPROVAL. Presiding Commissioner Mark Maples allowed time for anyone to speak for or opposed the recommendation. Brandon Herrold came before the Commissioners on behalf of the re-zoning, no one came opposed. The matter to approve the recommendation of the Planning and Zoning Board on the request to re-zone (parcel #14-9.0-31-003-022-001.003) for a Residential Garage was brought to decision by a roll call vote: Smythe – yes; Maples – yes; Blades - yes. matter not carried.
