### Open Bid for Snowplow and Plow set up

After reviewing the bids received on April 20, 2023, Brian Hackmeister, South Shop Foreman, recommended to go with Knapheide Truck Equipment to install a new 9ft snowplow, dump bed, salt spreader, with all the hydraulics. The matter to approve the bid from Knapheide Truck Equipment in the amount of \$60,181.00 was brought to decision by a roll call vote: Wilson – yes; Campbell- yes; Blades-Absent; Smythe –yes; Maples – yes. matter approved.
