**Approval of Commission Minutes**

**Great River Engineering – Jasmine Road Bridge**

John Cahill – Great River Engineering, came before the Commission with the contract for Jasmine Road Bridge Project. Contract reviewed.

**Open Bids – Message Board/water tank trailer**

Four (4) Bids were received for a solar powered message board for the South Road and Bridge Shop. The four (4) bids received were from:

- Mid West 1<sup>st</sup> Equipment                      \$18,000.00
- Streetwise                                      \$15,990.00
- Roadrunner                                    \$ 17,470.00
- Advanced Work Zone Services   \$19,900.00

Brian Hackmeister, South Shop Forman will take the bids and review them and bring back his recommendation.

Three (3) Bids were received for the water tank trailer for the South Road and Bridge Shop. The three (3) bids received were from:

- S&H Farm Supply                              \$14,500.00

- Midwest 1<sup>st</sup> \$13,125.00 (1,025 Gal) plus \$750 freight cost
- Midwest 1<sup>st</sup> \$16,187.50 (1,250 Gal) plus \$750 freight cost

### **Discuss equipment purchase**

Central Shop Forman, Carl Freeman came before the Commission with a source Well #011723-CAT bid for a rock breaker for a mini HYD Excavator for the amount of \$17,376.08. The matter to accept the bid for the Rock Breaker for the Mini HYD Excavator was brought to a decision by a roll call vote: Wilson – yes; Campbell- absent; Blades- yes, Smythe – yes; Maples –yes.
