Carl presented a bid from Corwin Ford of Republic for a 2026 Ford F-600 4X4 pickup truck using a Missouri Contract #MC250182003 for the amount of \$68,6871.00. Carl also presented a bid from Knapheide for the dump body bed, salt spreader, and snow plow with cutting edge for the amount of \$58,841.00. Napheide is allowing the County to use the same bid that the South Road and Bridge Shop used prior. The matter to accept the bids for a truck, dump bed, salt spreader and snow plow was brought to a decision by a roll call vote: Wilson – yes; Campbell – yes; Blades – yes; Smythe – yes.
