Approval of Commission Minutes

The matter to approve the minutes for Stone County Commission meetings dated September 9, 2025,

Schedule of Bills - 1

Presiding Commissioner Pro Tem Smythe presented a schedule of bills that have been submitted to

Open Bids - heating and air unit judicial building

After advertising, the County Commission received two (2) bids. The bids were from Knight Heating and

Air Conditioning and Price Heating and Air to replace two (2) heating and air units for the judicial

building. After reviewing the bids, Northern Commissioner Wayne Blades made the recommendation to

award the bid to Knight Heating and Air Conditioning for the amount of \$15,850.00. The matter to

award the bid to Knight Heating and Air Conditioning was brought to a decision by a roll call vote:

Approve Real Estates Purchase contract

After County Counsel William McCullah reviewed the contract from the City of Galena, the matter to

approve the purchase of the building located at 111 S. Main Street, the empty lot behind the old City

hall, and a partial lot behind the Planning and Zoning building for the price of \$75,000.00 plus closing

costs. The matter to approve the purchase of the property from the City of Galena was brought to a

decision by a roll call vote: Blades – yes; Smythe – yes.

Approve Torgerson – architect contract

After County Council William McCullah reviewed the contract with Torgerson Architects, the

recommendation to approve the contract for building B (Recorders office building) and not approve the

building A (Planning and Zoning/ Assessor's building remodel) as the contract reads. The matter to
